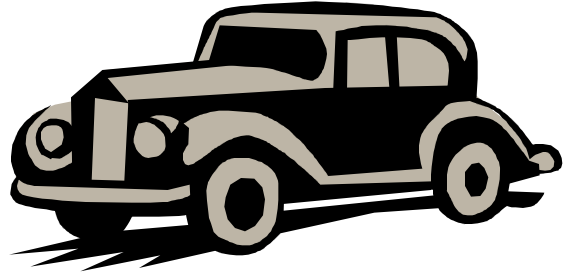


CRUISE THE GORGE 2004
